

I am very pleased to announce CFSAN/Milk and Milk Products Branch (MMPB) Headquarters certification of Mr. Patrick Frontale as a Single-Service Consultant (SSC) as provided for within the 2017 *Procedures*. Mr. Frontale was certified in accordance with the current provisions and standards of the National Conference on Interstate Milk Shipments (NCIMS) and the Federal/State Cooperative Grade "A" Milk Safety Program.

This SSC certification is valid for three (3) years, unless revoked for cause, and will expire on November 14, 2021. With this certification, it provides for Mr. Frontale to conduct IMS Listing certifications of foreign single-service containers and/or closures for milk and/or milk products manufacturers in accordance with the *Methods* and *Procedures* of the NCIMS program.

During the next three (3) years, Mr. Frontale must meet the following requirements to maintain his certification as a SSC:

1. Comply with the directives of the NCIMS Grade "A" Milk Safety Program as administered by FDA (*Methods* and *Procedures*);
2. Must not fail, without cause, to attend at least one (1) FDA Milk Seminar (*Procedures*);
3. Must accomplish at least one (1) foreign single-service containers and/or closures for milk and/or milk products manufacturers IMS certification annually (*Procedures*); and
4. Successfully complete CFSAN/MMPB independent side-by-side comparison of at least two (2) single-service containers and/or closures for milk and/or milk products manufacturers using the Items listed on FORM FDA 2359c-MANUFACTURING PLANT INSPECTION REPORT (*Single-Service Containers and/or Closures for Milk and/or Milk Products*). The candidate and PHS/FDA personnel shall be in agreement at least eighty percent (80%) of the time on each listed Item (*Procedures*).
